To the Cuyahoga County Fiscal Officer, Mayors, Council Members, Finance Directors, Clerk/Treasurers, and all interested persons:

Pursuant to Ohio Revised Code §1901.14, I am submitting the 2016 Annual Report of the Garfield Heights Municipal Court.

The Court's caseload and revenues continued to decline in 2016. Although the caseload declined by only 306 cases, total revenues declined by \$546,507.00. Collection of both civil and criminal/traffic court costs declined. Fines and garnishment payments declined. The decline in revenues is directly attributable to the increase in indigent defendants in criminal and traffic cases who do not have the ability to pay fines and costs and the number of out of work defendants in civil cases. In response to the declining revenues, we decreased payroll by approximately \$100,000.00 and general operating costs. As a result, the municipalities served by the Court will not be liable for any apportionment pursuant to Ohio Revised Code \$1901.26 for operating costs from 2016.

Through the efforts of our victim advocate and probation officers, the Court successfully collected restitution for victims in the amount of \$75,897. Cases assigned to the advocate have increased by 7.5% since 2015. The advocate has been able to successfully contact and advocate for victims in 79% of the criminal cases assigned and 76.5% of the traffic cases assigned.

The Court brought a new, interactive website on-line which enables litigants to learn more about the justice system, their rights and responsibilities, the proper procedures for trying cases and collecting judgments. The website has a virtual assistant and videos explaining many issues. View the website at <a href="mailto:ghmc.org">ghmc.org</a>.

The Court received technology grants from the Ohio Supreme Court totaling \$62,073.80 to assist the police agencies with software which enables them to file electronically with the Court; to expand the Court's ability to process credit cards and hire a 24 hour call center for payment of fines and costs by telephone and on-line; to purchase a new server; and to add audio technology to the Court's security system.

David Soros, the Court's Network Administrator was appointed to serve on the Ohio Supreme Court's Commission on Technology & the Courts, Case Management Work Group.
